Tuition Payment Information

- A *non-refundable deposit of **50% the practical fee** is due with the submission of this practical agreement. *This deposit is applied toward administration and registration fees paid up front.*
- Remaining balance of practical, plus any practice time is due upon completion of testing.
- Fees may be paid via Credit Card, Cash, Money Order or Company Check. Sorry, we do not accept personal checks.

*Some exceptions to the refund eligibility of the non-refundable deposit are made in the certain extenuating circumstances listed below. These exceptions are to be made with the permission of an Authorized Crane Wise Certifications administrative personnel only.

Cancellation/Refund Policy

- Applicants have two options when needing to cancel or reschedule a practical they have registered for:
 - **Advance Notice Cancellation:** An applicant who provides at least two (2) *business days advance notice in writing, via email, to the scheduled class start date will have two options: 1) Be entitled to a refund of all monies paid minus a \$25 administrative fee; 2) Opt to postpone for a later practical date and keep the deposit on file as an active credit for **one (1) calendar year**, with a refund of any additional monies paid. No monies would be forfeited utilizing option 2, as long as the credit is used within 12 months of the date payment was processed.
 - **Less than 48 Hour/No Show Cancellation:** An applicant who cancels within two (2) business days of their test date, or fails to notify CWC of cancellation (No Show), will have two options: 1) Be entitled to a refund of all monies paid minus the deposit; 2) Opt to postpone for a later test date within 175 days from original test date scheduled. If the practical is not taken within 175 days of original schedule date, the deposit will be lost-NO EXCEPTIONS.
 - **Forfeited Deposit:** If a deposit/payment has not been applied to a Crane Wise service, class or practical as described above, 100% of the deposit/payment will be forfeited one (1) calendar year from the date of processing.
- **Rejection:** An applicant that is rejected by the school for any reason before attending any scheduled class time is entitled to a full refund of all monies paid to Crane Wise Certifications. The applicant will receive in writing, the reason for the rejection, along with the refund via mail.

No later than thirty (30) business days of receiving written notice of cancellation from the applicant, Crane Wise Certifications shall issue a refund of all monies paid by the applicant minus the administrative fee stated above.

*Business days exclude Saturday, Sunday and/or all federal or state holidays

The applicant understands:

- CWC reserves the right to reschedule the practical exam date if the weather forecast is beyond the testing limitations set forth by NCCCO. Applicants are given at least 24-hour notice.

- CWC reserves the right to discontinue any applicant(s) training for any/or all of the following reasons: Nonpayment of deposit, failure to complete paperwork as required, and/or failure to abide by the school rules noted in this practical application.
- CWC does not guarantee the transferability of credits to a college, university or to any other educational or vocational institution. Any decision of the transferability, and/or the appropriateness of such is the decision of the receiving institution.

Crane Wise endorses the national certification program offered by the National Commission for the Certification of Crane Operators (NCCCO) and provides training to prepare candidates for CCO examination.

Setting up your myCCO Portal Account

Effective December 1, 2022, Crane Wise Certifications can no longer register new applicants in the NCCCO system. Applicants that do not already have an active Candidate ID will be required to register in the myCCO Portal in order to be assigned an ID number. Without a Candidate ID, Crane Wise cannot register applicants for any written or practical exams.

Applicants that already have a Candidate ID number (different from the NCCCO Certification number on your card) are also **required** to register in the myCCO Portal and verify their profile. Through this portal, you will be able to provide/update your contact information, apply for CCO exams, and see recent exam results and current certifications.

Please note: Crane Wise Certifications will still register all applicants attending our classes for their tests. Applicants are not required to register or pay for their own test fees, only to create an account and provide Crane Wise with their Candidate ID.

Previous myCCO Mobile App Users

Any candidates who created an account with the previous version of myCCO (through the mobile app) will be required to sign in and verify their email address so that they can take advantage of all the new features of myCCO. The mobile app version will still be available, but its functionality will be limited.

How to Register

Registering is quick and easy. Go to NCCCO.org on a computer or in an internet app and click on the button in the upper right-hand corner, [myCCO Login/Registration](#).

- If you have previously created an account in the myCCO app, login using the same credentials.
- If you have never registered with NCCCO and do not have a candidate ID number, you will register and create a new account. It is recommended to use a personal email (not a work email) since this will be associated with your NCCCO certification permanently.

Once logged in, you will need to verify or enter your personal information such as personal mailing address and phone number. Company information is not required.

On the main screen of the portal, to the right of your name is where you will see your CCO ID which is the candidate ID number that Crane Wise will need in order to register you for written and practical exams. Again, this number is different from your certification number that appears on your NCCCO Certification card.

Please provide this number in the designated space on your Enrollment Agreement or Practical Application.
